

Privacy Statement & Terms of Use

The College of Audiologists and Speech – Language Pathologists of Manitoba (the College) is the regulatory body for the professions of audiology and speech – language pathology in Manitoba. The College is mandated by the government of Manitoba under *the Regulated Health Professions Act* (RHPA) to carry out its activities and govern its registrants in a manner that serves and protects the public interest. The College regulates the professions by ensuring safe, competent, and ethical practise by its registrants.
