### **THE POSITION**

The Speech-Language Pathologist, based out of the SSCY Centre, provides services to the preschoolers and their families within Winnipeg (.2 EFT) as well as travelling out to the Dauphin area (.2 EFT) and Thompson (.5 EFT). Services are provided with a family centered approach in a team based, consultative manner under the direction of the Program Manager.

### **PRIMARY ACCOUNTABILITY**

1. Therapy service delivery to families, caregivers, and day care providers in community settings (primarily in homes and day cares).

### **GENERAL ACCOUNTABILITIES**

1. Collect and review consumer information to initiate assessment.
2. Select and administer appropriate evaluation procedures and tools.
3. Interpret, document, and communicate evaluation information through written and verbal reports.
4. Participate in conferences/meetings pertinent to consumers specialized needs. Participate and contribute to the development of children's programming through intake meetings/review meetings, IEP/ISP meetings.
5. Complete monthly statistical records regarding consumer caseload, and submit mileage, additional expenditures, etc. in a timely manner.
6. Establish effective collaborative relationships with consumers and collaterals.
7. Demonstrate leadership within the team through identification of program/consumer needs, issues, or service gaps, and participating on community committees, as requested.
8. Conduct/assist in formal presentations and workshops.
9. Maintain and replenish inventories of equipment, materials, and supplies.

10. Participate in student supervision or peer mentoring/supervision as requested.
11. Participate/contribute regularly in meetings pertaining to program development and /or professional development.
12. Complete CPR/First Aid training according to program requirements.
13. Practice in compliance with Privacy legislation (i.e., PHIA, PHIPPA, PIPEDA).
