

## **RHPA Jurisprudence FAQs**

1. Why do I need to understand jurisprudence?

By completing the *Regulated Health Professions Act* (RHPA) Jurisprudence Module new applicants and registrants of the College of Audiologists and Speech-Language Pathologists of Manitoba will gain a greater knowledge of the regulatory framework that guides the Audiology/Speech-Language Pathology Professions in Manitoba. The module highlights the laws and standards that are regulated under the RHPA providing one with a greater understanding of the scope of practice, and the roles and responsibilities of the College, registrant and the employer. Ultimately, awareness of jurisprudence will assist in the provision of safe, competent and ethical care.

2. Who has to complete the jurisprudence module?

Currently, eight Manitoba Health Regulatory Colleges, including CASLPM, must complete the *Regulated Health Professions Act* (RHPA) Jurisprudence Module (JM) as part of their Registration and Renewal process as mandated in each of the College's legislation.

For the 2023 CASLPM Registration and Renewal year, all Full, Provisional and Non-Practising registrants will have to complete the RHPA JM. In subsequent years, only the new and Provisional registrants will have to complete the RHPA JM.

3. How long will it take to complete the module?

The module takes between 1-1.5 hours to complete.

4. Do I have to complete the entire module at one time?

No. You can log in and out of the module and it will pick up where you left off. Make sure you click the "Finish" button at the end of each section and at the end of the module.

5. Can I complete the modules with colleagues?

Yes, you are welcome to complete the modules with colleagues to promote discussion and increased awareness. However, in order for you to receive credit for completing the module, you will need to log in separately to submit the responses to the practice scenarios. At the end of the module, you will receive a completion certificate that must be uploaded into Alinity to complete your registration and renewal.

6. Will I be tested on my knowledge?

No, the module will ask you questions based on practice scenarios. You can review the explanation under the discussion tab after selecting your answer, so you can fully understand the scenario.

## 7. Can I redo the module?

You can redo the module as many times as you would like.

8. What do I do if the module is not working?

Try using a different web browser, computer or device. Sometimes poor internet connections or firewalls can impact your ability to view the module, so using a different computer or viewing the module in a different geographical location may help you gain access to the module.

- 9. How do I upload the Certificate of Completion into Alinity?
- a. To upload the Certificate of Completion into Alinity for the CASLPM Renewal and Registration form it must be in a PDF or a JPG format.
- b. To save as a PDF
  - Type your name and date on the Certificate of Completion
  - Choose notes on the left tool bar so it says Certificate of Completion
  - Press the print icon next to the date
  - Change the layout to landscape so the whole certificate is visible
  - Click the option marked "PDF" in the lower left corner of the menu box that appears
  - In the drop-down menu, select "Save as PDF"
  - Save the file under RHPA Certificate of Completion, which will now be in PDF format.
  - You will then be able to upload the PDF into the Registration and Renewal form
- c. To save as a screenshot
  - Type your name and date on the Certificate of Completion
  - Take a picture of the Certificate of Completion with your phone and the JPG will be saved to your photos.
