The successful applicants will collaborate and consult with parents/guardians, educators, and community professionals, design communication programs, and provide supervision for these programs within the educational setting in the RRVSD schools.

QUALIFICATIONS:

- Must be registered, or be eligible for registration, with the College of Audiologists and Speech-Language Pathologists of Manitoba (CASLPM)
- Must have Master's Degree in in Speech-Language Pathology
- Must be in possession of a current School Clinician Certificate (Speech-Language Pathology) prior to the determined start date.
- Must be able to work in a collaborative manner with school personnel and parents
- Strong technology skills in order to complete all on-line recording and reporting requirements
- Vehicle is required

EXPERIENCE AND ABILITIES:

- Relevant school and clinical experience working with students with communication and/or language delays
- Assist school personnel in identifying students with communication impairments
- Familiarity with a wide range of assessments
- Determine individualized intervention goals and establish strategies and techniques to facilitate development of the targeted skills
