The speech language pathologist will support school teams with programming related to the speech, language and communication skills of students in order to maximize each student's learning potential and socialization within the school environment. This individual will be part of the Student Services Unit and will report to the manager of student services. The successful candidate will provide a broad range of educational services including:

- Professional consultation and collaboration
- Observation, screening and specialized assessment
- Intervention development, implementation and monitoring
- Development and programming related to alternative and augmentative communication including speech generating devices
- Supervision of the Speech Language Development Program
- Developing and facilitating professional learning for staff
- Co teaching to support classroom instruction

### **Requirements:**

- Master's degree from a recognized program in speech language pathology
- Possess or eligibility for membership with the College of Audiologists and Speech-Language Pathologists of Manitoba
- Clinician certificate or in progress
- Relevant school and clinical experience working with a broad spectrum of students with communication problems
- Strong collaborative and interpersonal skills
- Knowledge and understanding of the student-specific planning process
- Familiarity with assistive technology available to students with communication difficulties (software and speech generating devices)
- Ability and willingness to provide professional learning workshops to staff
- Ability to work collaboratively with a multi-disciplinary team
- Strong working knowledge of the optimal learning model and response to intervention process
- Access to a reliable vehicle to travel between schools in the division
- Upon hire, external applicants must supply a Criminal Record with Vulnerable Sector Search, and a cleared Child Abuse Registry Check, as conditions of employment
- Provide virtual speech therapy
- Strong knowledge of phonemic awareness is an asset
